Discussed DDPC's work with the Governor's office, other state agencies, legislators, the courts, family members concerned about guardianship and conservatorship issues, and New Mexicans in the Gallup area concerned about health care. Discussed appointment to serve on the Supreme Court Guardianship Steering Committee. Discussed budget process and budget adjustment request for Office of Guardianship.

### Division of Vocational Rehabilitation (DVR) Report

Diane Mourning-Brown discussed staff vacancies, working with UNM and NMHU to develop a career ladder, increased staff morale, and order of selection. Chinda Lucoski requested more information about job developers.

### Center for Development and Disabilities (UCED) Report

Pat Osborn discussed Partners in Policymaking program, HM 51 for autism programs, developing family peer mentor network and curriculum for adults with ASD, pilot project in group homes for individuals with "challenging behaviors," ASD registry funding request, and podcast for families.

#### **Disability Rights New Mexico**

Gary Housepian discussed DD Waiver waiting list, Medicaid community benefits, lawsuits against the state, special education clinics, and lack of education for children in residential treatment facilities.
