Barbara Ibanez announced DDPC has established a Jon Peterson Annual Award that will be given at the Statewide Summit on Advocacy to a nominee once a year who meets the Award criteria. The Award criteria reflects the passion and productivity that Jon Peterson had for Policy and Systems Change for people with developmental disabilities. The 2019 Award went to Daniel Ekman.

Wendy Corry reviewed Advocate Rights and Responsibilities, the Infrastructure project for Allies for Advocacy and her involvement with CSA Advocate Leadership Academy. Ms. Corry spoke on Sub-Minimum Wage Taskforce, which focused on HM16, with presentations on rules and regulations on 14-C's to pay sub-minimum wage.
